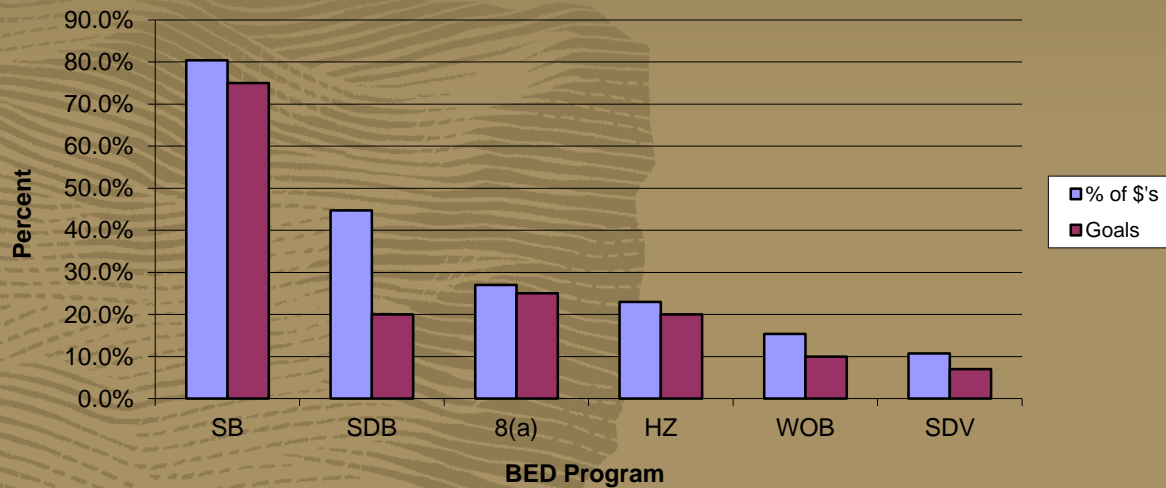
- \$300 - \$400 million under contract annually
